Film, Arts & Culture Projects in Pennsylvania, Alabama and Georgia Secure \$4 Billion Tokenized Financing via GMTX Exchange

Cheyenne, WY / Harrisburg, PA / Tuscaloosa, AL / Atlanta, GA – August 31, 2025 – A historic \$4 billion tokenized financing package has been finalized through GMTX.Exchange to fund large-scale arts and entertainment developments across Pennsylvania, Alabama and Georgia. The financing unites the Film, Arts, Culture & Tourism Specialist Inc. (FACTS) and the Global Infrastructure Finance & Development Authority Inc. (GIFDA) under a master resolution supported by local governments and structured through Platinum Media Inc.

The plan encompasses multiple cornerstone projects:

- Pennsylvania (\$1.76 billion) – including a \$1.2 billion studio sound stage & backlot campus, a \$250 million Arts & Entertainment College, a \$100 million Arts & Entertainment Museum, a \$200 million STEAM Academy, and a 5D/IMAX theater.
- Alabama (\$2.112 billion) – including a \$1.44 billion sound stage campus, a \$300 million Arts & Entertainment College, a \$120 million museum, a \$240 million STEAM Academy, and a 5D theater.
- Georgia (\$128 million) – construction of a regional sound stage campus.

The combined \$4 billion initiative is designed to transform these regions into world-class hubs for arts, film, education, and culture.

The foundation for this financing was laid in Dauphin County, Pennsylvania, where the Board of County Commissioners unanimously adopted Resolution #2022072A in 2022 establishing the Central Pennsylvania Film Commission. The Commission is administered by FACTS, a nonprofit 501(c)(3) created to promote, expand, and build infrastructure around film, television, and media in the region. In January 2025, the FACTS Board further advanced the effort by adopting Resolution #74461933, formally authorizing collaboration with GIFDA to finance critical infrastructure projects tied to arts, culture, and tourism.

GIFDA, a Pennsylvania-based not-for-profit infrastructure authority, will issue revenue bonds and manage financing under a Master Trust Indenture, with project ownership vesting in FACTS upon retirement of the debt.

“This financing represents a transformative leap forward for Central Pennsylvania, Alabama, and beyond,” said Johntrae Williams, President of FACTS and Executive Director of the Central Pennsylvania Film Commission. “The support of Dauphin County and the establishment of our Film Commission gave us the platform to connect local leadership with global financing through GMTX.”

Shah Mathias, board member of FACTS and principal of Platinum Media, added: “The county’s vision in authorizing the Film Commission has now matured into a \$4 billion real-world financing. Through GMTX

and Wyoming’s blockchain framework, we can bring transparency, efficiency, and global investment to projects that will anchor the arts economy for decades.”

As with all GMTX-regulated transactions, this financing was executed under the pioneering Wyoming Digital Asset framework, specifically W.S. 34-29-106(c)(g)(ii)(v), which recognizes tokenized smart contracts as enforceable legal instruments.
